Voluntary Release, Assumption of Risk and Indemnity Agreement

In consideration for being permitted to participate in a voluntary prayer ministry, herein referred to as the “Prayer Ministry”, the undersigned, _____, herein referred to as the “Releaser”, agrees as follows:

- 1. Release, Waiver, Discharge and Covenant Not To Sue:*** *Releaser*, and *Releaser’s* personal representative(s), assigns, insurer(s), heirs, executors, administrators, spouse and next of kin, hereby releases, waives, discharges and covenants not to sue *True Colors Apostolic Center, True Colors Apostolic Counseling Training School located at 74 Brick Boulevard, Building 1, Suite 110, Brick, NJ 08723* and its’ directors, officers, employees, agents, volunteers as well as its’ successors assigns, affiliates, subordinates, and subsidiaries, all herein referred to as the “*Releasees*”, from any and all liability to *Releaser*, and to *Releasees* of otherwise while *Releaser* is participating in the *Prayer Ministry* and any other activities in connection with the *Prayer Ministry* or training of various inner healing models.
- 2. Assumption of Risk:*** *Releaser* understands, is aware of, and assumes all risks inherent in participating in *Prayer Ministry*. These risks include, but are not limited to, physical and emotional responses and reactions as a result of this prayer ministry.
- 3. Indemnity:*** *Releaser* agrees to indemnify *Releasees* from any liability, loss, damage or cost *Releasees* may incur due to the participation by *Releaser* in the *Prayer Ministry* whether caused by the negligence of *Releasees* or otherwise. *Releaser* assumes full responsibility for any risk of bodily injury, death, or property damage due to negligence of *Releasees* or otherwise while participating in the *Prayer Ministry* inner healing tools for the total duration of the time of prayer counseling and all proceeding time thereafter with no statute of limitations.
- 4. ALL Pictures and Media:*** For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the *Releaser* gives consent and forever grants the *Prayer Ministry*, its representatives, licensees, marketers, and any other related parties or publishers of its promotional materials and their successors and assigns, the right to use, publish, and copyright my picture, portrait or likeness, in whole or part, including alterations, modifications, derivations, and composite thereof, in advertising and promotions throughout the world. This right shall include the right to combine my likeness with others and to alter my likeness by digital or other means. *Releaser* also hereby releases the *Prayer Ministry* and such other parties from any obligation to make and payment hereunder or from any other liability incurred in connection with the use of any materials described above. *Releaser* acknowledges his or her full and complete satisfaction with the terms of this release.

- 5. Audio and Video Recording:** I agree that I will refrain from any and all audio and video recording of any and all training sessions.
In the future, as True Colors Apostolic Center sets up a library of resources for registered students only, I agree to access and use the resources thereof for my sole personal use only as a registered student, and to abide by any future policies setup by True Colors Apostolic Center.

Releaser expressly agrees that this Voluntary Release, Assumption of Risk and Indemnity Agreement, herein referred to as the “*Agreement*” is intended to be as broad and inclusive as permitted by the laws of the State of New Jersey, and that, if any portion of this *Agreement* is held invalid, it is agreed that balance, notwithstanding, continue in full legal force and effect. This *Agreement* contains the entire agreement between the parties in regard to the *Prayer Ministry*.

Releaser Represents That:

I have carefully read this *Agreement*. I understand it is a release of all claims, including the negligence of releases.

I understand that I assume all risks inherent in the *Prayer Ministry* set forth in this *Agreement*.

I understand that I am indemnifying the *Releasees*.
